Explanation of Responses:

1. This amended Form 4 is being filed to correct the footnote description. The original Form 4 filed on May 16, 2011, incorrectly described a vesting schedule over the first four quarterly anniversaries of the date of grant, rather than vesting over the first 16 quarterly anniversaries of the date of grant. The corrected footnote appears in footnote #2.
2. Concurrently with the closing of RLJ Lodging Trust's (the "Company") initial public offering, the Company granted 25,000 restricted shares of beneficial interest in the Company to Mr. Morales, vesting ratably on the first 16 quarterly anniversaries of the date of grant, under the Company's 2011 Equity Incentive Plan.
